

### U.S. Army Veteran - Joe Cuddy

Born and raised in South Lawrence, Joseph Cuddy attended St. Patrick's Grammar School and graduated from Central Catholic High School in the Class of 1952. Joe played basketball,

hockey and football and ran track. After graduation, he enlisted in the US Army.

As the middle of 5 brothers, Joe's brother, Bill, graduated from Central Catholic in 1946 and enlisted in the Navy. John was in the Navy Reserve when he was in high school at Central, graduating in 1949, and enlisted in the Army and went to Korea. The Army

sent John to Officer Candidate School in Fort Monmouth, NJ then to Camp Gordon, GA. John was a Lieutenant Colonel when he retired from the Army Reserves.

Joe followed in his two older brothers' paths, by enlisting in the US Armed Forces in March 1953. His younger brothers Jim and Gerry lived, worked, and volunteered in the Merrimack Valley. Their children continue to follow in their footsteps.

Joe completed sixteen weeks of basic training at Fort Campbell, KY and attended the Airborne School at Fort Benning, GA and was assigned to Fort Bragg, NC. Joe joined the 187 Airborne Regimental Combat Team. He flew to Fort Lewis, in Seattle, Washington, as part of an Army six-member crew, where he was the clerk for the cruise. The ship traveled to the Aleutian Islands and continued onto Yokohama. He then took a train to Camp Chickamauga in Beppu, Japan. While in Japan, Joe attended Jumpmaster School. He completed 36 parachute jumps.

On his way home from Japan, Joe was part of "Operation Gyroscope" a United States Army program implemented where entire regiments were rotated out of overseas service together rather than as individuals. They stopped at Wake Island, in the western Pacific Ocean, an island which was attacked by the Japanese during WWII. The second



stop was in Honolulu and then in San Francisco. He slept in a swing seat against the wall in the plane. The group got off and got right back on at each stop. They had an emergency landing in San Francisco due to a lost engine. Joe was discharged in March 1956 as a Corporal.

Joe returned from his service in the Army and worked for New England Telephone in Lawrence as a lineman, while attending Lowell Tech, where he earned his degree in Engineering. Joe


That has to change.



# MA Senate Passes PACT Act 3.0 for Affordable Healthcare

In a historic move, the Massachusetts Senate unanimously passed the Act Relative to Pharmaceutical Access, Costs, and Transparency, commonly known as the PACT Act 3.0, on November 15, 2023.

This bipartisan legislation is a crucial step in urgently needed reforms to address the rising costs of prescription drugs and enhance transparency in our state’s pharmaceutical system.

The bill received widespread acclaim, finding broad support among legislators. Senate President Karen E. Spilka (D-Ashland) underscored the urgency of providing immediate relief from the escalating costs of prescription drugs, underscoring its alignment with the Senate’s steadfast commitment to affordability, equity, and transparency. In her words, “The urgency of relieving prescription drug costs becomes paramount when lives are on the line.

I eagerly anticipate the bill’s enactment, envisioning a future where residents and seniors paying a visit to the pharmacy counter will witness a tangible reduction in the costs of vital medications. This legislative reform mirrors the Senate’s unwavering dedication to addressing affordability, equity, and transparency, ensuring the Commonwealth remains a competitive and thriving place to live and work.”

Senator Michael J. Rodrigues (D-Westport), Chair of the Senate Committee on Ways and Means echoed these sentiments, expressing his satisfaction with the Senate’s approval of the crucial prescription drug legislation. As the Chair of the Senate Committee on Ways and Means, he emphasized the bill’s transformative impact on healthcare accessibility and affordability. In his words, “Healthcare is all about accessibility and affordability, and this reform-minded, consumer-focused bill will allow increased access to prescription drugs while also considerably driving down the cost of everyday medications. I thank Senator Friedman for her leadership on this and many healthcare issues, as this bill will literally save lives.”

The bill’s proponent, Senator Cindy F. Friedman (D-Arlington), a recognized leader in healthcare reform, conveyed her contentment with its passage and underscored its vital implications for accessibility and affordability. Senator Friedman, who serves as the Senate chair of the Joint Committee on Health Care Financing, highlighted Massachusetts’ pioneering role in healthcare services and the life sciences sector. She stated, “This bill begins to meet the urgency of this challenge by eliminating cost-sharing for generic drugs and capping out-of-pocket costs for brand name drugs used to treat insulin, asthma, and the most prevalent heart conditions. In addition, this legislation will provide much-needed relief for certain high-cost drugs, improve patient access to medications and pharmacies of their choice, and enhance transparency and oversight within the pharmaceutical industry. I thank President Spilka, Chair Rodrigues, my Senate colleagues, and the many stakeholders who helped craft and improve this pressing legislation. Massachusetts deserves a healthcare system that delivers affordable, high-

quality, and accessible care to all our residents, and this bill brings us one step closer to that goal. I hope this is the year we can get this bill signed into law.”

Key Highlights of the PACT Act 3.0 Lowering Costs for Life-Saving Medications:

The legislation focuses on providing immediate price relief and reducing out-of-pocket spending for prescription drugs treating diabetes, asthma, and chronic heart conditions. Importantly, it addresses disparities affecting Black and brown residents.

To achieve this, the bill mandates insurers to eliminate deductibles and cost-sharing for one generic drug and caps co-payments on one brand-name drug at \$25 per 30-day supply. This approach aims to improve access and mitigate the financial burden that often leads to the dangerous practice of rationing life-saving drugs.

Ensuring Patients’ Preferred Pharmacy Access:

The PACT Act 3.0 takes significant strides to ensure patients can obtain prescription drugs from their chosen pharmacies. It empowers independent pharmacists to dispense specialty medications and allows any network pharmacy to contract with carriers for mail-order prescriptions. This change disrupts the current practice of carriers determining available pharmacies for mail-order prescriptions.

Holding Drug Companies Accountable:

Enhanced accountability tools in the bill address rising medication costs and barriers to care. It empowers the Health Policy Commission (HPC) to identify high drug prices creating access barriers and recommend measures to increase patient access. Non-compliant pharmaceutical manufacturers face fees directed to a trust fund for a new drug cost assistance program.

Pharmacy Benefit Manager (PBM) Oversight:

To combat a potential driver of rising healthcare costs, the legislation introduces crucial oversight for Pharmacy Benefit Managers (PBMs), integral players in shaping the tiering and pricing of prescription drugs within insurance plans. PBMs are supposed to serve as intermediaries among health insurers, pharmaceutical manufacturers, and pharmacies, overseeing the management of prescription drug benefits for insurance plans. Their responsibilities include negotiating drug prices with manufacturers, establishing pharmacy networks, and processing prescription drug claims. Despite their intended role in streamlining the prescription drug supply chain, PBMs lack transparency and have had an impact in increasing drug pricing. Their practices such as rebate negotiations and formulary management contribute to increased costs for patients and restricted access to certain medications.

The PACT Act 3.0 seeks to address these concerns by implementing oversight and regulation for PBMs, ensuring alignment with the best interests of consumers and the broader healthcare system. Currently, PBMs operate with minimal oversight, leaving uncertainties about whether they prioritize the best interests of consumers or health plans during negotiations with pharmaceutical manufacturers. Under the PACT Act 3.0, the Division of Insurance (DOI) is empowered to address this gap by



instituting essential oversight through the licensing and regulation of PBMs, coupled with sanctions for those failing to meet specified standards.

Furthermore, both pharmaceutical manufacturers and PBMs will now participate in the Health Policy Commission’s (HPC) annual Cost Trends Hearings for the first time. This inclusion in the hearing process mandates the provision of public testimony regarding the factors influencing drug costs, accompanied by supporting documentation. The HPC will leverage this information to conduct a thorough analysis of how pharmaceutical industry costs impact the state’s healthcare market, ultimately influencing the overall cost of healthcare for residents of Massachusetts.

Protecting 340B and Future Steps:

I am proud to have contributed to the bill’s success by introducing an amendment to ensure safety net hospitals and community health centers can purchase discounted drugs through the federal 340B program.

The amendment was a crucial measure aimed at safeguarding the integrity of the 340B program, particularly benefiting our safety net hospitals and community health centers. Recognizing the paramount importance of quality and affordable healthcare access in my district, as well as in Gateway Cities and BIPOC communities statewide, it is evident that our safety net hospitals and community health centers serve as a lifeline for countless low-income and uninsured residents.

Safety net hospitals, exemplified by Lawrence General Hospital with the highest urban, stand-alone community hospital inpatient volume of 10,543 discharges and 14,280 patients in FY22, and community health centers such as the Greater Lawrence Family Health Center operating across seven community locations in Haverhill, Lawrence, and Methuen, play a pivotal role in delivering a diverse array of essential services.

At the heart of this support is the 340B program, a federal program that empowers institutions like Lawrence General and the Greater Lawrence Family Health Center to acquire pharmaceutical drugs at discounted

rates from manufacturers. This program significantly enhances the financial flexibility of our safety net hospitals and health centers, allowing them to expand services and deliver a more comprehensive level of care. Notably, the Lawrence Family Health Center has utilized its savings to hire translators, community health workers, fund medication therapy management, and broaden pharmacy access.

However, recent challenges emerged as drug manufacturers and distributors imposed restrictive measures on 340B-covered entities, hindering the utilization of third-party contract pharmacies. Beginning in 2020, these restrictions, varying between manufacturers, limited health centers to a single contract pharmacy or, in some cases, barred their use altogether if the health center had an in-house pharmacy. This impediment made it harder for health centers to procure and distribute 340B drugs, subsequently restricting funds available for patient services.

To address this issue, I presented an amendment that will rectify existing ambiguities at the state level by explicitly prohibiting manufacturers and distributors from obstructing the acquisition or delivery of a 340B drug to a pharmacy under contract with a federally qualified 340B health center or a safety net hospital. While this amendment is a crucial step toward ending discrimination against 340B program participants, it is acknowledged that it doesn’t cover all entities.

As we move forward, we remain committed to expanding protections for all 340B-covered entities and addressing discriminatory practices. Together with my bill, S.704, aimed at prohibiting practices by Pharmacy Benefit Managers, we strive to restore the intent of the program and ensure accessible, affordable healthcare for all Massachusetts residents.

The PACT Act 3.0 now awaits consideration in the Massachusetts House of Representatives. As we champion comprehensive pharmaceutical reform, I am optimistic about the positive impact this legislation will have on the health and well-being of our communities. ◇

# Our State Government’s Failed Immigration Policy

Back in 2022 I had the honor of representing Massachusetts on an Immigration Task Force for the National Conference of State Legislators where I joined state legislators from across the country to find ways to fix our broken immigration system.

What I remember most is that after just a few zoom meetings, where we outlined problems and issues, we finally met in person in Washington DC to come up with a final policy statement. It took just a single day.

There were no Ds or Rs in the room, (Democrats or Republicans), no blue team or red team, just a couple dozen state legislators who recognized how the cost of the federal government’s failure on immigration policy fell on cities and states and how it didn’t have to be this way.

And the costs are not minor with some estimates at about \$150 billion per year as the net cost at the federal, state, and local levels. In Massachusetts alone we’re spending about \$45 million per month just for housing new migrants, but the overall costs are substantially higher when factoring in things like food, clothing, healthcare, education, and law enforcement. The scary part is that nobody seems to know what the overall cost to the Commonwealth is, only that it’s growing every year.

Done correctly, immigration becomes more of a solution than a problem and we need only look to places like Australia, Canada, and Germany to see examples of how this could work.

Done incorrectly and we need look



no further than across the pond to UK and Europe where right-wing political parties are gaining power and winning elections because voters are pushing back against uncontrolled immigration. Worse yet, history shows that out-of-control immigration leads to the rise of hate groups which is happening both here and abroad.

This shows us yet another example of how political parties are at the root of our problems, producing a tribalism that leads to inaction in our governments and deep, damaging divisions in society. Some on the far left want to abolish agencies like ICE and CBP, and decriminalize illegal border crossing, while some on the far right want to close our borders

and end birthright citizenship, which is guaranteed under the Constitution. Meanwhile, moderates on both sides fear primary challenges from within their own party if they appear too willing to compromise.

This is crippling in a rapidly aging country like ours where we have a severe worker shortage, especially in crucial jobs like doctors, nurses, teachers, police officers, and military personnel. A well-run immigration system would benefit our economy by helping to fill those needs instead of hurting it with new arrivals who will be a drain on public finances.

Within the next ten years Medicare and Social Security will begin to run out of money as more Americans retire. Those programs rely on workers paying into them to keep them solvent and immigration can be a solution, if only the parties would get out of the way. ♦

# Health Care and the Haverhill Fire Dept.

First, I'd like to wish a Merry Christmas and Happy Hanukkah to all those who celebrate. Let us all enjoy a time to get together and enjoy quality time with family and friends. I look forward to 2024 and building on all that was accomplished in 2023!

In November, the Massachusetts House of Representatives unanimously passed legislation that takes a comprehensive approach towards reforming the long-term care industry by supporting and expanding the workforce, enhancing oversight of facilities, and ensuring greater access, all while prioritizing quality of care. This legislation took in mind several recommendations from the Nursing facility task force.

- Providing the Department of Public Health (DPH) with additional tools to monitor and take punitive action against facilities, including new abilities to limit, restrict, suspend, or revoke a license for

cause and appoint temporary managers;

- Strengthening DPH's licensure suitability standards to include a more comprehensive review of the background and legal record of applicants and expanding the scope of review to include any entity with at least 5 percent ownership interest in a nursing facility; and
- Creating new initiatives to support and grow the workforce, such as workforce training grants to develop new Certified Nursing Assistants (CNAs), career ladder program grants, and leadership and supervisory training.

This piece of legislation goes a long way and holding facilities accountable also gives them the tools they need to keep our loved ones in long-term care facilities safe.

This past week, I joined Congresswomen Lori Trahan, the Haverhill State delegation, and local dignitaries to present a 4.1 million grant to the Haverhill Fire Department. This grant that the Haverhill Fire Department



applied for, and Congresswomen Trahan secured, will provide the City of Haverhill with 16 new firefighters over the next three years.

This will allow the fire department to staff another ladder truck. This truck will be located at the Bradford fire station. This will severely reduce response times to the Bradford and Ward Hill sections of Haverhill.

Due to the work of Congresswomen Lori Trahan and the Haverhill Fire Department, there is no doubt in my mind that the residents of Haverhill are safer now than they were before.

I look forward to continuing to work with the Haverhill Legislative Delegation and the Haverhill Fire Department to enhance the city's fire services further and ensure our firefighters are given the equipment to keep themselves and our community safe.

Whether you grew up in Lawrence, Methuen, Revere, Winthrop, Brighton, or Boston, every community in the Commonwealth values kitchen-table issues; an honest day's work, safe streets, affordable homes, good schools, access to quality and affordable healthcare, and the ability to earn a good living and save for the future.

Just last month, we were able to pass a historic Tax Relief Bill which will make the Commonwealth more affordable, competitive, and equitable by putting real dollars directly back into the pockets of hardworking Bay Staters. Whether it's by increasing the child and dependent tax credit for families or lowering the capital gains tax so folks see more of their money when they invest in their Robinhood or Fidelity accounts, this legislation will provide immediate relief and opportunities for working class people fighting hard every day to make a living.

There's more work to be done. It's no secret that for much of this country's history, the financial system has been largely closed off to most Americans. Teachers, plumbers, steamfitters, steelworkers, nurses, members of the military, and men and women in uniform simply have not always had the same opportunities to save and build wealth as the one percent.

Until recently, owning stocks was largely reserved for older, wealthy, and less diverse Americans, including those with the means to pay a financial professional to do it for them. Fortunately, recent innovations aimed at empowering a new age of investors tore down these barriers, reshaped our financial system, and paved the way for

a massive influx of new investors into the stock market. These millions of new investors are younger, more diverse, and come from every community and every part of the country, including hundreds of thousands of people right here in Massachusetts.

Not only did this transformative shift expand access to the stock market for an entirely new generation of Americans, but it has also made finance and investing more approachable and relevant to millions of people who had previously avoided it because of its intimidating and exclusive nature. Today, technology has democratized investing with easy-to-use, low-cost mobile platforms like Robinhood that for the first time provide tools allowing ordinary Americans to save a little more, make a few extra dollars in income, and invest in great American companies they believe in, including companies that are based here in the Commonwealth. These new platforms have not only simplified the act of purchasing a stock, they've increased the overall relevance and interest in personal finance. Whether it's through podcasts, newsletters, or in-app education modules, these platforms are using technology to communicate with and educate investors, making financial literacy more accessible by breaking-down complex concepts such as compounding and dollar cost averaging, as well as the differences between a traditional and Roth IRA and the implications of a 'wash sale' or capital gains.

We must encourage these platforms, who are uniquely positioned, with their reach and resources, to continue prioritizing financial literacy with the understanding that developing a new generation of informed investors will lead them to a more sustainable financial future. We also need to



promote sound policies that will help keep these new investors involved for the long-term while protecting them from fraud and abuse. Unfortunately, recent efforts by financial regulators are threatening to throw these new investors right back out of the markets. At both the state and federal levels, securities regulators are considering new rules that, while intended to protect investors, would strike at the very heart of the online model most prefer to use to invest today. These rules could even make it impossible for financial providers to use the very same innovative technologies that have brought millions into the stock market in the first place.

And they are likely to disproportionately harm those underserved populations that for decades have been told they aren't smart enough or wealthy enough to invest.

We reject this narrative, as do many of our colleagues. We've personally spoken to our neighbors – construction workers in Lawrence, firefighters in Revere, cab drivers around Boston, and the staff here in the State House – many of whom tell us that they feel more empowered and equipped than ever before to make their own financial decisions.

These are normal people who don't necessarily have the resources, the need, or the desire to completely turn the management of their finances over to expensive professionals. Instead, they've gravitated toward affordable and easy-to-use mobile platforms that allow them to take a more hands-on approach in managing their finances.

These investors deserve strong, sensible regulations that protect them from fraud and abuse, but they also deserve the opportunity to participate fully in our financial system and achieve the American dream. We will continue to fight in the State House for policies that give our communities both. ♦

# Veterans’ Benefits and Ride Share Drivers

I want to start this month’s column with a big ‘Thank You’! Thank you for reading into and engaging with the work of your elected officials. It is a joy of this job to hear constituents’ advocacy and carry their voices to the State policy-making level. I am thankful to every one of you.

This month I was excited to recognize and remember our veterans. I sit on the Committee of Veterans and Federal Affairs, so I am highly attuned to the issues regarding veterans. I will continue to advocate for veteran support here at the State House.

In my community, I was excited to give out buckets for veterans filled with supplies to assist those through the cold winter months. The buckets were donated to the State House and handed out to veterans across the state. If you or someone you know is a veteran and has any questions, comments, or concerns, please reach out to my legislative aide Laura (laura.byman@mahouse.gov) who will assist you with where to take your question.

Also at the State House, this November’s calendar was full of committee hearings in preparation for closing out the First Session. During a



Committee hearing, anyone can testify in support or opposition to the bill on the docket.

The committee members either favorably report a bill, meaning they recommend the passage of it, or they give an adverse report, signaling that they want the bill to be killed.

Committee members vote based on testimony, research backing the bill, and their political ideology. If you feel inclined to advocate for or against a bill, please check out [malegislature.gov](http://malegislature.gov) for more information on how to do so.

An important piece of legislation this month that I co-sponsor is H.1099,

An Act establishing a transportation network driver bill of rights. This bill gives rideshare drivers the right to organize and protect themselves against retaliation from organizing. It bars unions from coercion and requires them to represent workers fairly through a bargaining unit of 25% of the eligible voters.

Bargaining is industry-wide. Many constituents advocated in support of this bill, which is another reason I was happy to support it.

Representatives are also able to testify on legislation. In my testimony for H.1099 I shared that our current system is failing rideshare drivers. These drivers often rely on a large portion, or all, of their income to provide for themselves and their families.

The uncertainty of their pay, high demand, ever-evolving technology, and manipulative practices by the companies, creates high levels of stress and can be emotionally taxing. We as state legislators must take action to protect these workers and their worker rights. I believe in workers getting the money they deserve.

# The Year in Review: 2023 in Dracut

As we get ready to usher in a new year, here’s a look at some of the highlights and happenings from 2023 in Dracut.

\* The Dracut Scholarship Foundation’s annual telethon raised more than \$162,000. Since it began, the scholarship foundation has awarded nearly \$2 million in scholarships to 1,700 Dracut High School graduates. Every year, the Dracut Scholarship Foundation Telethon brings out the best of Dracut, shining a bright spotlight on our community’s long-term commitment to helping DHS students.

\* It was a quiet town election in Dracut this year. There were no contested races. Chairman Alison Genest and Heather Santiago-Hutchings ran unopposed for Selectman. Genest topped the ticket for her second town election in a row, winning seven of the town’s 10 precincts, and was subsequently re-elected to serve as Chairman of the Board for a third year. In the School Committee race, Chairman Renee Young was the only candidate. Likewise in the race for Dracut Housing Authority, where incumbent George Nangle also had no challengers. In the Dracut Water Supply District election, Gay Corey and Peter Natsios were the only two candidates for Commissioner.

\* Neighborhood residents raised questions and a variety of concerns about a 300-unit affordable housing development proposed for East Dracut on the site of the former Murphy Farm. The development is expected to impact every aspect of town government, including the schools, due to its large size.

Murphy Farm is one of 12 housing

developments currently in the planning stages in Dracut that are expected to bring about 900 new housing units to town. In addition, a state housing mandate calls for Dracut to accommodate another 1,200 new housing units or lose state grant funding. State legislators passed that measure with the intention of providing housing in communities near MBTA commuter rail stations. To comply with the law, the town must create a new zoning district that allows for 15 housing units to be built per acre, which the Zoning Bylaw Review Committee is working on now to meet next year’s deadline.

\* Speaking of zoning bylaws, as member of the Zoning Bylaw Review Committee, which was charged with overhauling the town’s zoning bylaws for the first time since the 1980s, Selectman Heather Santiago-Hutchings totally zoned out.

Those zoning bylaw changes were supposed to come before town meeting for consideration in June, but the Board of Selectmen and residents were so blindsided and concerned by the number, scope, and potential impact of the proposed changes--and lack of communication about them--they were pushed forward to November.

Instead of focusing on policies, Heather-Santiago Hutchings had been focused on politics. She spent a considerable amount of time and effort trying to change the makeup of the committee and get her political buddy Phil Thibault appointed. Thibault, a perennial candidate who has lost nine town elections, including electoral contest against all five sitting selectmen, was ultimately rejected for the seat. The Board of Selectmen cited conflict of interest, as Thibault is an architect who

conducts business in town with builders, contractors and others governed by the zoning bylaws.

\* Former Dracut Selectman Sheila Richardson celebrated her 90th birthday this year at a surprise party held at Harmony Hall. It was standing room only for the celebration, which brought together many of Richardson’s family, friends, and well-wishers. As you may recall, Richardson was a force in local and state politics for decades. In addition to serving on the Board of Selectmen and Housing Authority, she was a member of the Massachusetts Republican State Committee and founder of the Dracut Republican Town Committee.

\* 20-year-old Christian Lemay of Dracut was acquitted of first-degree murder and related charges in the 2020 Lowell shooting death of 20-year-old Adrian Kimborowicz.

\* When Chairman Joe Wilkie unexpectedly resigned from the Dracut School Committee, Phil Thibault popped up again, with perhaps the shortest candidacy in town history to fill the unexpired term. Thibault announced he was in the race and then a nanosecond later he was out. In between, Thibault apparently realized he was unable to muster five votes from the Board of Selectmen and School Committee. Members of those two boards ended up unanimously appointing Rob Sheppard, a guy who actually ran for school committee last year and finished third in that five way-race behind winners Allison Volpe and Dr. Linda Trouville.

\* Town government continued to focus on adding personnel to the public safety ranks. Three new firefighters joined the Dracut Fire Department:



Ryan Talbot, Dylan McCarthy, and Jacob Martin. Four new police officers, all Dracut natives, joined the Dracut Police Department: Owen McAnespie, Aimee Levesque, Leah Papageorgiou, and Kevin Steere.

\* Dracut also said goodbye to some good friends this year. Tom McAnespie, former member of the Dracut School Committee and legal counsel for the Dracut Water Supply District, passed away at age 59. Former Dracut High School Principal Bruce Hutchins passed away at age 82. Retired Dracut Police Officer Harry Curtis passed away at age 71.

\* Finally, in one of the most moving and memorable moments of the year, 99-year-old Dracut veteran and volunteer Pat Walor was honored with the Joseph Bradley Varnum Award for his military and community service.

# Methuen Police Receive \$400K Grant to Create Clinical Community Response Team

METHUEN — CEO Matthew Page-Shelton and Police Chief Scott McNamara are pleased to announce that Front Line and the Methuen Police Department will receive a two-year, \$400,000 grant to fund the addition of a clinical co-response clinician with the Methuen Police Department, as well as the creation of a civilian Community Response Team.

The addition of a clinical co-responder and a Community Response Team that can provide urgent psychotherapy services means the Methuen Police Department will soon have a comprehensive mental health program in place throughout the department.

The \$400,000, two-year grant comes from the U.S. Department of Justice’s Office of Community Oriented Policing Services (COPS Office).

“Methuen Police and Front Line Services understand the need to divert

behavioral calls for service away from emergency rooms and criminal justice system by utilizing a clinically trained team that can meet the needs of the community,” said CEO Page-Shelton. “We are extremely grateful for this grant funding, which will provide us with a pathway to do far more to meet community needs.”

Methuen Police and Front Line Services will use this grant funding to provide access to a master’s level trained clinician and Community Response Team that will provide direct support to the community through crisis response and post-crisis outreach.

The goals of this project are to decrease the behavioral health calls for services responded to by law enforcement alone, to decrease unnecessary emergency room visits and criminal arrests, to increase connections to outpatient supports, increase initial

engagement in cross-over/bridge supports post-crisis, and to increase equitable access through providing culturally and linguistically competent services to the community.

“This grant is a big deal for us, as it will enable us to create a comprehensive Mental Health Division within the Methuen Police Department, and to add a master’s level trained clinician to work with those in our community who experience crises,” said Chief McNamara.

“This will be a major improvement in our ability to compassionately and effectively deal with increasing numbers of mental health calls, all while providing services that can help reduce such calls for service by getting those in need connected with community resources.”

The grant funding comes in addition to a \$550,000 Justice Mental Health Collaborative Partnership grant from the

Department of Justice, Bureau of Justice Assistance that will also help to fund the creation of the community response team, and which will fund the creation of a community support center in Methuen to bolster behavioral health services to those within the community.

The Community Support Center will provide Methuen Police a place where officers can refer individuals who are suffering from substance use or other behavioral health challenges for follow up care that includes post-crisis outreach, and supports that include peer support, benefits support, social determinants support, and therapy. It is expected to be opened by October of 2024.

The co-response clinician and Community Response Team are expected to be working by early 2024, with additional programming and resources rolling out over the next year.

# Voter Fraud Investigation in Lawrence ... AGAIN!

Just a few short days before Election Day in Lawrence, a video went viral on social media, reportedly showing a campaign volunteer for a city council candidate stealing absentee ballots from people’s mailboxes.

The video shows a woman - well known in Lawrence political circles, getting out of a red car, going onto a neighbor’s porch with something in her hand to make it look like she is delivering a parcel of mail. But when she gets to the mailbox, she takes out the absentee ballot and then gets back into the red vehicle to drive away.

Sources at the Lawrence Police Department say that the person driving that red vehicle was caught on a city camera at the next intersection after the mailbox theft, and that the person driving the getaway car is one of Lawrence’s newly elected city councilors.

So, I called the new Police Chief, William Castro to ask him if he is investigating this allegation of voter fraud, and whether or not they have a city council candidate on the city cameras driving the getaway car.

Here’s what he said:

“The Lawrence Police Department is presently assisting with an investigation into allegations of mail fraud.”

“The Lawrence Police Department received two complaints about stolen mail-in ballots, and we called the District Attorney’s office, Secretary of State Bill Galvin’s Office, and the Post Office to investigate. Secretary Galvin’s Office has assigned the case to District Attorney Paul Tucker, who is actively investigating the complaint. This is an active investigation.”

Castro would not admit that it was a newly elected councilor caught on the city’s camera system, but one source close to the investigation said that the plate number and occupants of the vehicle have been easily identified.

Experts in election fraud told the Valley Patriot after the incident that even if the voter fraud was committed by a successful candidate for city

council, and even if that person is arrested and convicted, there is no mechanism whereby that elected official can be removed from office, or prevented from being sworn in come January.

In fact, no elected official has ever been removed from office - or prevented from taking office - for engaging in voter fraud, or any fraud for that matter.

That means the newly elected councilor who drove the getaway car in this case, can take office in January and serve out the two-year term she was elected to serve, regardless of what the criminal justice system does to her and her cohort for stealing absentee ballots.



EMERGENCY PARKING BAN: Alternate Parking on Certain Streets between 12:01 AM to 6AM

The winter alternate parking ordinance shall only take effect during the dates and times specified in a “SNOW AND ICE EMERGENCY” issued by the Mayor or his/her designee, The snow emergency shall remain in effect until the Mayor rescinds it. Notice of any such rescission shall be given in the same manner as the issuance of the declaration.

Winter Alternate Parking shall mean that on the following streets, between the hours of 12:01 a.m. and 6:00 p.m., daily, vehicles shall, unless otherwise prohibited by law, be parked on one side of the street only, so that on the even-numbered dates of the calendar, vehicles shall be parked on the even-numbered sides of the streets, and on the odd-numbered dates of the calendar, they shall be parked on the odd-numbered sides of the streets: ORD 10.36.031 **(\*IF YOUR STREET IS NOT LISTED BELOW, NO PARKING IS ALLOWED\*)**

# Alternative House: Empowering All Survivors to Self-Sufficiency

Kane learned the following information from the National Coalition Against Domestic Violence

- Nearly 20 people per minute are physically abused by an intimate partner in the United States.
- 1 in 3 women and 1 in 4 men experienced some form of physical violence by a partner.
- 1 in 4 women and 1 in 7 men have been victims of severe physical violence in their lifetime.

It was Kane’s privilege to meet with Maria Crooker-Capon, Executive Director of Alternative House. Maria has worked at Alternative House for 17 years total and has a contagious vibrant personality.

She is passionate about her work and prides herself on creating a strong network of services in the local community by partnering with the police department, City Manager’s Office, and many social services agencies. Maria’s professional degrees are in Business and Non-Profit Management instead of social work like many nonprofit agencies. Kane thought this was a genius idea since Maria has a lot of energy for networking, social media presence, grant writing, and program management.

Alternative House located in Lowell MA is committed to empowering all survivors of intimate partner violence and other forms of domestic violence to achieve self-sufficiency so they may live in the safe environment deserved by all beings. Founded in 1978, Alternative house has served thousands of survivors of domestic violence in the Greater Lowell area. Kane calculated this as 45 years of working to end domestic violence. Kane said, “this is very impressive and important work.”

Founded in 1978, a group of women who took part in the Battered Woman’s movement, paved the way for the agency to provide services to thousands of survivors. This original movement



was developed to bring awareness and an end to violence against woman. Alternative House is one of three funding agencies of the greater Lowell Evaluation and Advocacy network (GLEAN) which is a high-risk assessment /rapid response team as well as the founder of the city manager’s task force against domestic violence. Alternative house is a member of the Jane Joe Incorporated/ Massachusetts coalition.

Maria stated “Our trained domestic violence advocates are available 24 hours a day/7 days a week /365 days a year. Kane learned that to date in 2023, Alternative House has assisted more than 2,000 clients. Maria told

Kane that they receive 10 to 15 calls a day needing assistance and often space. Maria explained that the work is very high risk, and they value their partnership with the local police departments as they observe high risk protocols to keep staff and survivors safe. Maria explained to Kane that the model is very “grass roots” as her employees hit the pavement each day. Maria said, “the quicker you get involved with survivors, the sooner they accept services.” Kane learned from Maria that the need for safe housing is much greater than the spaces that are available.

Although there are 7,000 emergency beds available in the state only 167 are

set aside for domestic violence. Kane learned that Alternative House has 8 funded beds and one that is not funded. It is common that Maria has to pay for emergency safe houses in hotels since the need is so high.

For immediate assistance call the hotline at 1-888-291-6228.”

To achieve safety and self-sufficiency, Alternative House not only provides emergency shelter and a 24-hour hotline, but access to safe temporary housing, transitional / permanent housing, legal advocacy, supervised visitation services, housing advocacy, support groups, youth and teen programming, as well as daily access to case management, safety planning, goal setting, financial empowerment, and career planning and placement.

These services are available for all survivors of domestic violence and their children who seek help. Kane was impressed by the space. Maria created a beautiful inviting environment for survivors to meet and children to participate in groups and after-school activities.

Maria explained to Kane that Alternative House is funded by contracts with the office on Violence Against Woman (OVW), the Massachusetts Department of Public Health, (DPH), the Massachusetts Office of Grants and Research through the Violence Against Woman, USA Department of Justice, and the Department of Housing and Urban Development for Violence Against Woman Funding.

# Lawrence Firefighter Paul King Honored by Governor Healey

At the 34th Annual Firefighter of the Year Awards

WORCESTER - MA Governor Maura Healey and State Public Safety Secretary, Terrence Reidy joined State Fire Marshal Jon Davine to honor firefighters from across the state at the 34th annual Firefighter of the Year Awards ceremony, where Lawrence Firefighter Paul King was honored last month.

“Each year, the Firefighter of the Year Awards recognize acts of bravery, heroism, and service that are truly remarkable – even by the remarkable standards set by Massachusetts firefighters,” said Governor Healey.

Shortly after midnight on May 22, 2023, the Lawrence Fire Department responded from a nearby box alarm to Haverhill Road near the Spicket River for a reported car over the bridge. On arrival, they found a vehicle upside down in the water. As crews started to don their survival suits, witnesses stated that the driver was drowning. Firefighter Paul King, the chauffeur on Ladder 5, determined that the driver’s life was in grave danger.

In his Class B uniform, he fought his way through the fast-moving river, opened the door and found the driver struggling to breathe. Firefighter King pulled the man to safety, and when the man said two others were still inside, he returned to the submerged vehicle ready to make additional rescues. Finding no one, Firefighter King came back to shore and coordinated a high angle technical rescue to raise the patient to EMTs, who were about 15 feet above. Dive teams did an extensive search and fortunately found no indication of anyone else in the water. ◇

affect the next election, there’s literally nothing they can do about it.

Legally, they cannot refuse a voter registration card or even investigate suspected fraud. In fact, they are not even allowed to compare the signature on a mail-in voter registration form with the signatures they already have on file to make sure the new voter registration is legitimate, even if the signature is an obvious forgery.

Furthermore, if you suspect your neighbor is illegally voting and you file a complaint against him, the government charges YOU with voter intimidation instead of investigating the fraudulent voter. So, who is going to bother?

HOW THEY CHEAT

There are a hundred ways to steal votes and change election results. Here at the Valley Patriot, we have witnessed and reported on many of them. The rest of the press won’t pick up our stories because it disproves their political narratives.

In one Lawrence election we watched a volunteer from a mayoral campaign sign up to be an election worker at the polls on election day.

Shortly before the polls closed, she would text her friends the names and addresses of people who had not voted, and with a minute or two left before polls closed, her friends would show up using those names and addresses to get a ballot, and vote.

In another election we watched a mayoral campaign go door to door with the city census - which is a public document. The city census lists all residents including non-voters.

The candidate would knock on doors with a “Motor Voter” card and an absentee ballot application and convince nonvoters to sign up to vote and then request an absentee ballot by mail. This was long before COVID was used as an excuse to increase mail in ballots.

Then the candidate would go back to those addresses after the absentee ballots are mailed so they can “help them” vote. He then offers to drop off their ballot at city hall to save them a stamp. If the new voter didn’t vote for that candidate, those ballots never made it to city hall. If they did, those ballots were hand delivered.

In the meantime, while the candidate’s volunteers were going door to door, anyone with a political sign on their lawn for his opponent, would have their absentee or mail-in ballot taken out of the mailbox (much like the video on social media this year).

When Willie Lantigua first ran for mayor against Dave Abdoo in 2009, Abdoo campaign workers caught Isabel Melendez (Lantigua’s manager) on video handing actual ballots to people outside the Mary Immaculate voting precinct with the names of Lantigua and his slate of candidates already filled out.

Candidates would take those ballots into the polling booth with the ballots that were handed to them by the election workers, use the filled in ballot as a template to fill out the blank ballot, and then put BOTH ballots into the voting machine.

The machine only counts one of those ballots, but if there’s a recount or a challenge, all of the ballots in that box - including the fake ones - get taken out and hand-counted. In a close race, those fraudulent ballots make all the difference.

I suspect that happened again this year as Lawrence City Councilor Rich Russell has now reported a discrepancy in the total number of ballots cast.

“After looking at the purge list and the ‘official results’ of the election, I find that according to the official results, 5,169 ballots were cast; yet when I look at the ‘purge list’ I find that only 5,021 residents of Lawrence voted, for a difference of 148 votes.”

The “purged list” is the list of names crossed off on election day as each voter gives their name and address to election workers.

Considering one Lawrence City Council race was decided by only 5 votes, and several other races were decided by less than 100 votes, those additional 148 ballots would have made all the difference.

DON’T HOLD YOUR BREATH

Having said all of this, it’s pretty clear, that the woman in the video stealing absentee ballots and the city council candidate driving the getaway car will probably face no consequences for committing election fraud.

If the Democrat Secretary of State, and the Democrat District Attorney, and the Democrat Attorney General - were to actually file charges and make a public claim of election fraud against these two political operatives, it would blow the Democrat Party narrative that voter fraud is nothing but a “Republican talking point.”

They would have to publicly interview witnesses in court about HOW elections are - and have been - stolen in Lawrence over the years, and who has been responsible for said fraud.

Trust me when I tell you, NOBODY in government wants that to happen. Nobody.

So, you can bet that once again, this will all go away quietly, and end up among the many stories people tell about all the stolen elections in Lawrence. All the while the media and the Democrat Party repeat the lie that voter fraud doesn’t exist.

In the meantime, I want to encourage every level of law enforcement to defy the political puppet -masters of the Democrat Party and expose every single detail of the many instances of voter fraud that have taken place in Lawrence over the last few years.

# NELF Files Brief to Assist MA Land Court After U.S. Supreme Court’s Tyler Decision

## Governments Must Refund Money From Properties Taken in Tax Title

BOSTON – The Massachusetts Land Court finds itself in a quandary that the New England Legal Foundation (NELF – [www.newenglandlegal.org](http://www.newenglandlegal.org)) helped to create. Earlier this year, the US Supreme Court issued its decision in *Tyler v. Hennepin County*, 598 U.S. 631 (2023), a Minnesota tax case in which NELF filed an earlier amicus friend-of-the-court brief supporting the taxpayer. The Supreme Court held that when property is taken to pay delinquent taxes, any value above the tax belongs to the taxpayer and cannot be kept by the government. Like the law of some other states, Massachusetts law has long permitted government to keep the entire value of the property. To do so is now unconstitutional.

In a tax case called *Town of*

*Tyngsborough v. Recco*, the Land Court justice asked NELF and several others to advise whether there may be a way for it to serve two masters, i.e., Tyler and current state law. Can it foreclose on the property and pass title to the town without denying the taxpayer her right to her home equity?

In its brief, NELF suggests a way. It notes that one isolated sentence in the law is responsible for government’s obtaining the unconstitutional “absolute” title. NELF calls attention to the Court’s statutory duty to try to save partly unconstitutional statutes if possible. NELF argues that the sentence may permissibly be severed because to do so would not harm the rest of the statute or related statutes. With the sentence gone, the town would be

able to obtain (non-absolute) title and sell the property for the taxes, while the Court could rule that the taxpayer retains an enforceable equitable interest in all sale proceeds above the taxes.

NELF emphasizes that the severance, so far from re-writing the law, would accomplish the state Legislature’s two prime purposes of facilitating the collection of delinquent taxes while protecting the interests of the taxpayer.

NELF President Dan Winslow commented, “Cities and towns need the ability to collect and enforce payment of local taxes to pay for important services like police, firefighters and teachers.

But such enforcement must respect the property rights of homeowners by preserving home equity value

once all taxes are paid. NELF’s proposed approach solves the issue in Massachusetts.”

Educated by the Earl: Second Sons of London Series

Prolific writer and USA Today Bestselling author, Alexa Aston, has penned a new Regency Historical Romance series The Second Sons of London.

The novel takes place during England’s Regency period. (Shortly after the colonies signed the Declaration of Independence.) The eldest son inherited the estate, the second son was relegated to the military, and the third to the clergy.

A group of seven-second sons meet in school. Through unexpected situations these young men come into their family’s inheritance. Knowing only the military they are lost when they return to society to claim their family’s title, estates, wealth, and power that result from such. A new life, with new rules to learn.

Along with the second son, the reader is taken on a journey into English society and all it entails. The roles of women and men are regimented yet vastly different. The ladies they encounter are not what they expected. Conflict increases as their search for the perfect mate intensifies.

Women understood that their sole duty after marriage was to provide their husbands, and his line, with a male heir. And, of course, a spare would be nice. After she performed her “duty” both husband and wife tended to lead separate lives. But, what if both wanted more? Could love factor in somewhere?

The search for a mate was played out during “the season”. A young woman’s coming out, similar to a Sweet 16 or a Quinceanera, was a time when she actively searched for a husband. This in-depth process involved what parties she attended, how many dances she could have with the same man, etc.

It was a very controlled, and well-organized ritual. Rules abounded. Breaking the rules had the potential

to lead to ruin, or at the very least, ostracization.

Ruin could occur for a number of reasons. The second book in this Second Sons of London series, Debating with the Duke gives a great example of how easily a woman can be manipulated into marrying someone that she may not be so inclined to wed. (I would recommend this book as well.)

Each book is a stand-alone. Ms. Aston takes a different approach to her series; her storyline concludes at the end of each book. One can pick up any book in the series and not feel lost due to an unending storyline.

Normally in a series, one must read the subsequent books to learn the conflict’s conclusion. And, in many cases, one must continue reading the series because the plot continues from novel to novel with no real resolution.

The only issue I had with both books was the love-making scenes. The quote “A cook in the kitchen, a whore in the bedroom” sprung to mind. The fact that these sheltered, very conservative women, once married, suddenly turned into women sexually free and willing to experiment did not ring true to me. Their change is so immediate that it seems unnatural and unbelievable.

I enjoyed delving into a different time period and learning how a different class of people dealt with a lifestyle very different from our understanding of life and society today.

I would recommend the first as well as the second book in this series. Both are quick, light reads with fulfilling endings. So, on a chilly winter’s night, snuggle up with a cup of hot chocolate, and pull out one of Ms. Ashton’s books. Enjoy. I did.

What if God  
Was One of Us?

Let’s play an imagination game. Let’s imagine that the invisible almighty Creator of the universe, who infinitely transcends the created order of time, space and matter, decided to become part of His creation. Like an author who writes Himself into his own novel, or an artist who paints himself into his own masterpiece, let’s imagine the God of the universe chose to become part of His creation.

Impossible, you might say. How could an eternal spiritual being that transcends creation possibly become so diminished as to enter space and time to become a mortal finite being? We could ask a similar question about the painter or the author. How could one possibly become a two dimensional being on a canvas or the other a character that comes alive within the pages of a book? Yet, in both instances, they are able to do it. The analogy for the eternal almighty Creator holds: It is possible to exist in two different dimensions, in two realms of reality (time and eternity), simultaneously.

And then, if this were to ever occur, if God were to become a mere human being – “If God was one of us” as pop singer Joan Osborne once imagined – wouldn’t everyone’s natural reaction be absolute awe? Wow. It would seem everyone’s first priority, by far, would be eagerly to know what He said and did. What could be more important?

Let us take stock of all the world’s great religious leaders in history. Have any of them made such an unimaginably lofty claim? Buddha never said he was God. Nor did Abraham or Moses claim divinity. Mohammed never made such a claim, nor did the Dalai Lama, Mani, Lao Tzu, or Confucius.

Every other religious leader claimed to have an enlightened message or a way of life to share; but none of them claimed to come down from Heaven to take on a human nature – except for Jesus. Virtually all non-Christian scholars concur that Jesus was a historical person and that He claimed to be God. Indeed, He is the only bona fide religious leader in history to make this claim.

This must be taken further. By following reason, one must consider the meaning of this unfathomable claim. One conclusion we can be certain of, without any religious faith, is that Jesus cannot be what most non-Christians claim Him to be: merely an enlightened teacher or prophet. That’s because, as C.S. Lewis once pointed out, for someone to claim to be God, and if that claim is false, he would have to be either a liar or a lunatic. In other words, if the claimant isn’t God he’s either delusional or evil. Logic dictates, therefore, that if Jesus is not



what He said He was, He could never be trusted as a teacher or prophet.

Since logic limits the possibilities of Jesus’ true identity to Lord, liar, or lunatic, let us look at them a little closer. Would a liar possess the moral character of Jesus? Would a deliberate deceiver hold to His principles unto death if he could have slivered out of it as a skilled liar? And could such a lie last over two millennia? Most lies are uncovered rather quickly. The next option, being crazy or delusional, would elicit as little trust as being a liar. And could someone who is mentally deranged be so lucid in His parables and sermons, and so masterful in His verbiage when stumping the Scribes and Pharisees – who at the time, themselves, were masters of self-serving deception? Any honest person who reads the gospels, with or without faith, knows that Jesus was neither a liar nor a lunatic.

This leaves only one viable option, only one possibility for Jesus’ true identity: He is the incarnate God who came down from Heaven to reconcile us to the Father for our eternal salvation. No other option is feasible.

During this Advent and Christmas season it is fitting to express that awe mentioned above: Awe that the one God of the universe was born to the world, through Mary, in the small Middle-Eastern town of Bethlehem. As we celebrate the birthday of the incarnate second Person of the Trinity, there’s no time like the present to make a (deeper) commitment to know and love the God who humbled Himself to become human, to suffer and to die in order to conquer death for the rest of us.

Merry Christmas and happy newness of life.

THE DOCTOR IS IN!

Lives Destroyed

I do believe that we have to have more wisdom and not only apply in life what we were brainwashed to automatically apply. A specialist doctor should not see his own specialty in every patient that comes through the door. We should not diagnose everybody with a heart disease just because we are a cardiologist. It is happening all the time. Sorry for saying this, but I have seen the damages that we cause. Let me explain.

As an example:

I really saw very many kids go crazy and get life disorientation when they go through the change. It is known that the sex hormones mess up the brain at the beginning, even in animals (I saw documentaries about this happening in young dolphins and elephants).

When children are having adjustment problems, they are often taken to a psychiatrist. They get started on meds, psych meds, antidepressants, addictive tranquilizers, stimulants, or antipsychotics.

These are not always very effective in curing the “illness”, so on the second visit, more meds are added.

Some children, with time, get interested in the relationships they are having, the studies or the job, or maybe a hobby. They stop the meds and end up living a normal life.

Other kids and parents get afraid of stopping the medications and stick with the psychiatrists and the medical system. The meds are numbing chemicals. These kids stay on them and become zombies. These same meds increase appetite, and so now, we get into obesity, poor self-esteem, joint pains, diabetes, high blood pressure, abuse, sleep apnea and persistent depression. Their life is ruined.

I am not against psychiatric help at all, but this is happening and is cruel and it is happening more than you think. There is no blood test for bipolar disorders, and we are always told that we, doctors, miss making the correct diagnoses. To avoid blame, we feel proud that now we are diagnosing them, often, even when they are not there. A little anger, a little misbehavior is not due to a bipolar disorder diagnosed and treated for life.

Both parents and doctors want a fast fix because handling difficulties in life is very stressful and we are all busy. So, it is easier to turn the child into a drugged zombie and keep the child out of our busy difficult life. Sad!

I was in Spain over the summer. In Spain, you have to have a special visit with your primary care physician (PCP) once a year with the main reason to reconsider your diagnosis and review your meds. This should be done even more often, but they do it at least once a year. Many of us doctors here in the US do not do this. ♦

# “Lessons In Chemistry”

‘Lessons in Chemistry’ is a terrific new limited series based on the popular novel of the same name and is my recommendation for this month.

The series stars Oscar winner Brie Larson as chemist Elizabeth Zott, who has long been underestimated simply because she’s a woman living in America in the 1950s. We first see Elizabeth standing before a live studio audience as she hosts her wildly popular TV show Supper at Six. But she never intended to become a television personality. Her first love is science, which we soon find out when the show flashes back to 7 years prior and we are told her story.

When we see Elizabeth 7 years ago, she was struggling for recognition while working in a world-renowned chemistry laboratory. She’s a brilliant chemist, but sexism in the lab relegates her to filling coffee cups for the men, even if she is one of the keener minds within Hastings Research Institute. Elizabeth decides to borrow some chemicals from another lab to complete a project, this lab belongs to Calvin Evans (Lewis Pullman).

Calvin, the equally socially awkward and award-winning chemist, lives in a primarily Black neighborhood and resides next door to Harriet (Aja Naomi King), a mother of two who continues to fight social injustice, including a freeway being built that will segregate their neighborhood from the rest of the community.

Calvin’s discovery of the missing chemicals causes him to confront Elizabeth. At first, Calvin is oblivious to Elizabeth’s trials as a woman. She’s looked down upon for not having a PhD, which she didn’t finish after being sexually assaulted by a superior.

Yet, they share the same interest in abiogenesis, meaning the theory that life originated from nonliving matter. Their

meeting radically changes both of their lives.

Calvin and Elizabeth are two loners who eventually come together, as the two bond over a mutual passion for science as well as an appreciation for good food. Their relationship is as charming as it is inevitable, living together with a dog named Six Thirty (“excellent name. After carbon and zinc, I assume?” says Calvin. But actually, named after the time he wakes up Elizabeth every morning.)

To give away too much more of the story, such as how Elizabeth goes from a struggling chemist to a famous television personality, would be criminal. Viewers deserve to watch how the story unfolds.

The show has great acting from top to bottom. Brie Larson delivers one of the best performances of the year and will definitely be remembered at Emmy time. Pullman and King also give excellent, poignant work here. Alice Halsey is perfection later in the series as Elizabeth’s precocious daughter, who’s determined to solve a family mystery. Even Six Thirty gets his own time to shine when we see an episode through his eyes.

Fans of shows like Mad Men, The Marvelous Mrs. Maisel and The Queen’s Gambit will find much to like in ‘Lessons in Chemistry,’ a solid, addictive prestige drama full of incredible performances, inspiring characters, and one of the best TV romances in some time.

# The Christmas Story

Could it be possible that since Joseph was a just man, he read Isaiah 50:1-4, which reads, “The LORD asks, “Did I sell you as slaves to my creditors? Is that why you are not here? Is your mother gone because I divorced her and sent her away? No, you went away as captives because of your sins. And your mother, too, was taken because of your sins. 2 Was I too weak to save you? given me his words of wisdom, so that I know what to say to all these weary ones. Morning by morning he wakens me and opens my understanding to his will.” NLT.

The Bible says that Joseph was pondering all his options, one of which was divorce. I remember my first encounter with the D-word, which was code for Divorce back in the 1970s. Every Christmas as a family we would watch the Andy Williams show with the Osmond brothers and in the year 1970, it was announced that Andy Williams and his wife separated and later divorced in 1974. I was immediately filled with sadness and despair. I thought for sure this was a mistake, but unfortunately, it wasn’t.
